

Sorbitol Solution 70% (1)	71.42 g
Sodium Saccharin (1)	2.00 g
Hydrogen Peroxide 35% <sup>(1)</sup>	0.57 g
Methyl Paraben (1)	1.00 g
Propyl Paraben (1)	0.30 g
Flavor (1)	0.10 g
Purified Water	q.s to 1000 ml

#### Manufacturing Guidance for 1000 ml

Easy manufacturing steps, no special mixer device needed

- Blending: Blend Magaldrate Gel 20%, Anhydrous Citric Acid, sodium saccharin, sorbitol, and parabens into water (100 – 200 ml)
- 2. Dispersion: add a suspension of Xanthan Gum at 0.5% to 1.0% and flavor
- 3. Homogenization: q.s with purified water to 1,000 ml




#### Physical Characteristics of the suspension produced from Starting Formula

**Appearance:** Thin creamy thixotropic white to off-white suspension, easy to re-suspend with a gentle shake.

Specific Gravity: 1.00 – 1.10
